FIMVO CHANGES SYSTEM SUPPLIER: OPB TRANSACTIONS CANNOT BE MADE ON NOVEMBER 18

Solidsoft Reply (SSR) has been chosen as the new system supplier for the Finnish Medicines Verification System. The switch to SSR's new interface in the production environment will happen during night time on November 18th. Note that the switch does not require any activities from marketing authorization holders/manufacturers or pharmaceutical companies. However, it is not possible to perform any OPB transactions in the Finnish NMVS during that time.
