**IMPORTANT – Renewal EU Hub Certificates & Alert endpoints**

5<sup>th</sup> April 2022

**THE BELOW INFORMATION IS OF CRUCIAL IMPORTANCE. PLEASE FORWARD THIS MESSAGE TO YOUR TECHNICAL TEAM AND/OR CONNECTION PROVIDER**

To ensure technical security, the EU Hub uses certificates with a validity period of 5 years. **In June 2022**, the public EU Hub Certificates must be renewed. To **remain connected**, please follow the actions defined below:

1. Download and configure your system with the new public EU Hub certificates for all endpoints except for the alert endpoints, between **April and 5<sup>th</sup> June 2022**. EMVO will inform you immediately when the new certificates are available on the OBP Portal.

Note: The new certificates of the **alert endpoints** should only be **configured when** the EU Hub **R1.11 is deployed** (See action 2).

2. At the date when the EU Hub R1.11 is deployed, the new public EU Hub certificates should be configured for the alert endpoints of the applicable environment. Be aware that the deployment in the Production Environment (PRD) of EU Hub R 1.11 will take place over a weekend. EMVO will soon communicate the exact dates.

To ensure the system is configured properly and timely, **EMVO advises you to keep your technical team & connection providers** well-informed on this topic.

As the updates of the EU Hub certificates and endpoints are critical to remain connected to the EU Hub, EMVO will organise five (5) separate Q&A sessions that aim to provide further guidance. Below you will find more information for each session.

Note that the attendance per session is limited to 250 participants. The sessions will be recorded and made available following each meeting.
